### Police Issues

There have been no issues highlighted in the village at present.

PSCO Hannah Burns introduced herself and explained that she is responsible for the Masson ward of Bonsall, Cromford and Matlock Bath.

Black Tor Road – a speeding vehicle has been reported and a resident was threatened by the motorist when challenged and asked to slow down.

Bonsall Moor - PSCO Burns was informed of the issues around the off road vehicles using the Moor for motoring activities.

PSCO Burns has visited the school and talked to the children.

The Safer Neighbourhoods meeting is to take place on the 29 April at Bonsall Village Hall.

#### Derbyshire County Council Issues

County Cllr Ratcliffe suggested that the PC contact the Peak District National Park regarding the off road vehicles using the Moor.

The application for Dunsley Mill is to be presented to DCC committee on the 10 March 2008. The PCT have acknowledged the difficulty for people in rural areas being able to access the breast screening facility, being removed from Darley Dale. Consultation regarding this closes on the 20 February.

Dobb Lane has now been classified as a restricted by-way, for walkers and horse riders only. Any motorcyclist caught using it will be prosecuted. Further work on the other paths is still on going.

Former Dist Cllr Don Whittaker who was a councillor for the Masson ward died at the weekend. His funeral will take place at 1pm on Friday.

#### Derbyshire Dales District Council Issues

Dist Cllr Hume reported that the district council have objected to the application for a goods vehicle operators licence for Ball Eye quarry. It has been reported that residents at Upperwood Road in Matlock Bath have complained about blasting and vibration from Ball Eye quarry.

#### Village in Bloom

The district council have given permission for the PC to use the land on Yeoman Street and the school are going to take on the maintenance of the land. The school are keen to be involved in the project, and are going to enter the East Midlands in Bloom painting competition.

Still to be clarified are the position of the baskets and tubs the PC will provide and who will carry out the watering.

A number of pot holes have been reported in the village which need repair.

A spate of fly tipping has been noted on the Moor – this will be reported.
